Addendum to the Minutes: Treasurer's Report

#### Calgary Duplicate Bridge Association Treasurer's Report March 31, 2014

The Unit's financial transactions for Fiscal Year ending March 31, 2014 were tracked against a balanced budget with final numbers reflecting a "budget surplus" of \$929. This positive outcome resulted from a significant boost in revenues from sectional tournaments, up by \$3,100 (+ 75 %) and reduced net expenses for phone directory, Kibitzer and travel subsidies. Major expense offsets included an unbudgeted Travel subsidy (\$2000) for the Worlds and a donation (\$2000) to the recent Canadian Bridge Championships.

Members Equity grew to \$45,553 - increasing by the budget surplus noted above and the transfer of funds previously "held in trust" for Calgary sponsored regional events.

Approximately 80% of our money is held in Term Deposit accounts with varying maturity dates and interest rates. This is essentially unchanged from 2013. Our strategy is to hold approximately \$10,000 in our operating account.

A budget for the current fiscal year has been provided with this financial report. Of note is a \$5000 allowance for equipment – new and replacement. If this expenditure is actually incurred, the budget shortfall will be \$4075 requiring funding from members' equity reserves.

The Association owns a trailer, bidding boxes, tables, boards with cards and Bridgemate units. These items are not capitalized on our Balance sheet.
