### Addendum to the Minutes: President's Message

### Unit 390 President's Report 2017

It is with great pleasure that I am able to report that the membership of Unit 390 increased by almost 5% over the period April 2016 to April 2017. The membership at April 1<sup>st</sup> 2017 was 942 up from 898 a year ago. This should be viewed in the light that overall membership of the ACBL has been more or less constant at 167,000 for the past few years. I believe that this increase can be attributed mainly to the work of the bridge teachers in Calgary. Over the past year there have been three weekend boot camps conducted by Nancy Klym and Bev Mason that attracted 115 participants. In addition courses offered by Linda Walker, Jane Lamont, Rae Haaland, Clarende Duby and Sandra Evans have offered players the opportunity to learn bridge on weekday afternoons and evenings so that access to instruction is available to all. Abdul Fakih is currently providing instruction on Friday mornings and Marilyn and Murray Haggins are providing new players the opportunity to play duplicate with their peers in a bid and play session. Many, many thanks to all these teachers.

Last October Audrey Grant brought her Better Bridge Festival to Calgary. The objective of this cross Canada tour was to raise funds for the Canadian Bridge Federation, which it did successfully. The Festival also provided people the opportunity to become accredited bridge teachers at no cost. The feedback from the 53 attendees was very positive.

The 4<sup>th</sup> Annual rookie/master teams game was held at the Kerby Centre on 4<sup>th</sup> February and attracted a record 38 teams, which was a 50% increase from last year. Thanks to all the volunteers and the organisers, Tracy Horan and Dev Drysdale, who did an excellent job and for their contribution to an enjoyable evening.

The four sectional tournaments held over the past year attracted 1060 tables. The increase in fees to \$11 per session has resulted in additional revenue for the Unit which will be passed back to the participants in the form of additional hospitality. The new location at the Clarion Hotel will be the venue for the next two years since we have been able to negotiate a favourable rental agreement.

Nicholas and Judith Gartaganis represented Canada at the World Bridge games in Poland last September. Out of a field of 53 they reached the quarter finals before being knocked out by the losing finalist, Monaco. They were inducted into the Canadian Bridge Hall of Fame recently and will be the subject of an article in the June edition of Bridge Magazine.

A telephone directory in a different format was published this year. In addition to the list of phone numbers the directory also contains a diary, a listing of the bridge clubs and the times of the duplicate bridge games in Calgary and area. Thanks to the editor, Judith Gartaganis, and to the Calgary Community Bridge League for their contribution to the publishing costs.

This year saw the webmaster responsibilities being taken over by Dan Bertrand and Doug Mann from Dave Swadron. Dave had carried out the webmaster responsibilities for the past few years and with his wife Marilyn was awarded the Jack Murphy Memorial trophy in 2015 in recognition of lifetime service to the Calgary bridge community. Dave passed away on Sunday, April 9<sup>th</sup> 2017. He will be missed.

Last January a significant number of bridge players in Calgary made their TV debuts at the filming of Fargo. The setting was at the Wildcat Regional in 2010, somewhere in Minnesota. The stars of the show, Ewan McGregor and Carrie Coon, believe they can make big money playing bridge! Good luck to them. However, the experience of being on a film set was a novel experience and seeing the amount of effort that goes into a film clip that lasts less than three minutes was enlightening. It is no wonder that TV shows cost so much to make.

There has been no success so far in getting a volunteer to tackle introducing bridge into schools. Although that will be a challenge, the rewards are substantial since studies have conclusively proven that playing bridge improves students' grades. If anyone will consider taking on the challenge please contact any board member.

The success of Unit 390 can be attributed to the effort of many associate board members who carry out their responsibilities diligently. I wish to acknowledge the thanks of the board to the following:-

#### TREASURER'S REPORT

#### MARCH 31, 2017

The Unit's financial transactions for the year ending March 31, 2017 generated an operating surplus of \$3,368. This outcome resulted from a combination of positive and negative items.

Noteworthy are increased revenues of \$1,752 from the four Sectional Tournaments held in the year. In addition, trailer and equipment rentals increased by \$2,079 from the Regional Tournaments held in Red Deer and Lethbridge in 2016.

Offsetting the increased revenues, the Unit spent an unbudgeted \$2,778 to purchase some new Bridgemate terminals and some new hinged boards which will be used at upcoming Sectional and Regional Tournaments.

All other items in the Statement of Operations were in line with the amounts budgeted. Members' Equity rose to \$39,474 as at March 31, 2017.

The budget for 2017-2018 will be debated and approved by the new Board of Directors at the next board meeting.

The Unit owns a trailer, bidding boxes, tables, boards with cards, Bridgemate terminals and a board duplicator. These items were expensed when purchased and are not capitalize on our Balance Sheet.
