Welcome and Introduction

John Sharpe, President, called the meeting to order at 11:40 a.m. He introduced the members of the 2017-18 Board and thanked them. He also thanked those members who are not returning to their positions: Dev Drysdale, Tracy Horan, and Delores Hedley.

Treasurer's Report

Ed Lamb, treasurer, presented the financial statements for 2017-18 and the budget for the coming year. Nick Gartaganis queried the reason for the large increase in hospitality expenses for the year. Ed responded that the cost of the Special Meeting in March to approve the By-Law changes accounted for the increase. Andrew Serafini asked if regional fees would be going up. Myron Achtman mentioned that there are expenses attached to teaching bridge in the schools. Keith Falkenberg moved and Barbara Webster seconded that the report be accepted as read. Carried. Addendum to the Minutes: President's Message

Unit 390 President's Annual Report - 2018

The membership of Unit 390 did not achieve the stellar performance achieved in 2016-2017. However, the membership over the period April 1st 2017 to March 31st 2018 did increase by 7 to 949. In April another 15 joined to bring the total to 964. This includes 13 new temporary members. Whether or not the new policy of the ACBL, which requires temporary membership of the ACBL to play in a Sectional or Regional, will lead to more membership in the long term remains to be seen.

The Unit has provided additional opportunities for newer members to achieve silver points by holding two 299er Sectionals. These were a great success and attracted over 240 tables. Thanks to Tracy Horan, Dev Drysdale and all their assistants in making these events so successful.

Unfortunately the other event geared towards rookies, the Rookie / Master team event, had to be cancelled owing to a major winter snowstorm. Hopefully the event this coming February will not suffer the same fate.

The Sectionals continue to be well supported, attracting 1149 tables compared with 1060 last year, an increase of 8%. I believe that this indicates that the new venue at the Clarion has been accepted and that Carrie Stockman and her tournament committee are doing a great job. The new table covers designed and made by Caroleigh Houghton are also contributing to a more professional environment.

A Special Meeting of the Unit was held on March 24th with the objective of modifying the bylaws and the proposed changes were approved. In the old bylaws the number of directors was fixed at nine (9) and the officers, i.e. President, Vice President, Secretary and Treasurer, were elected by the membership, not the board. Consequently the directors did not have the authority to appoint a successor following the resignation or removal of an officer during their term of office. The new bylaws have changed the number of directors to between seven (7) and twelve (12) and the election of officers is now a board responsibility. In addition there were several minor changes to improve clarity. As a consequence this meeting will be shorter than previously because the membership will no longer have to appoint the officers. The meeting turned out to be rather expensive for the Unit since the Clarion provided sufficient pizza to feed the 5,000, not the 60 members in attendance.

It is still early days for the 2018 Mentorship Program, but it is hoped that the new Mentorship Vision, Purpose and Strategic Plan 2018, which is available on the website, will provide clearer guidelines for both mentors and mentees as to what is expected from program participants. Thanks to Brian Johns and Sandra Evans for taking over the responsibility for this program and to Janet Sharpe for handling the distribution of the free plays. Thanks also to Nancy Stewart for her leadership on the program over the past several years. It is much appreciated.

The applications so far have not included significant interest from members in the 200 to 750 masterpoint range for either mentees or mentors. I do not understand this but request that if you know of

anyone in this range please suggest to them that there are significant advantages in becoming involved with the program. As a mentee the advantages are obvious, but as a mentor there are also benefits associated with having to make sure that your knowledge of conventions, card distributions, safety plays etc. is absolutely clear so that you can impart that knowledge successfully.

The Ace of Clubs and Mini-McKenney awards for the Unit will be handed out later in this meeting. However, I wish to recognize players who achieved success at the District and National levels. In the Mini-Richmond, which is a Canada wide event, Michael Serafini was the winner in the 5-20 point category and Dorothy Mersereau was the winner in the 500-1000 point category. In the District 18 Mini-McKenney there were eight (8) winners from Unit 390. Robert Stothers 0-5, Michael Serafini 5-20, Danuta Trafford 20-50, Brent Muir 100-200, Mary Anne Crookes 200-500, Dorothy Mersereau 500-1000, Helen Dillen 1000-1500 and Nicholas Gartaganis 10,000+. Robert Stothers, Michael Serafini and Brent Muir were also winners of the District 18 Ace of Clubs. Congratulations to them all.

The Unit has modified the travel policy with most subsidies being increased 100%. Although this subsidy does not come close to covering the costs of attending the finals of the Grand National Teams, the North American Pairs or the Canadian Bridge Federation Championships, it does help and hopefully will encourage more people to enter into these events.

On the topic of the Canadian Bridge Federation Championships, I am not sure that many of you are aware of the marathon endurance required to win this event. The round robin lasts for four days, followed by a day and a half quarter final, a day and a half semi-final followed by a two day final. A total of 466 boards over nine days. Quite the endurance feat and I am pleased to announce that Judy and Nicholas Gartaganis were again on the winning team and will represent Canada at the World Series in Orlando in September. I am sure that you will join me in wishing them every success.

The Unit has been unsuccessfully attempting to introduce bridge into schools for the past few years. I am now delighted to report that this past year Myron Achtman contacted Gary Strother, the Superintendent of the Catholic School Board, and with his assistance has successfully introduced bridge into St. Jude's Elementary school in Woodbine. He has a class of 10, reduced from the initial complement of 22, which was too many to handle. There were 14, 40 minute bridge classes held during lunch times and at the conclusion of the program the students were displaying excellent bridge etiquette, were able to play no trump, major and minor suit contracts, and weak 2's.

The school principal, Robert Brabec, is excited about continuing the program this fall. However, to expand the program there is clearly a need for more instructors. Myron has a lesson plan that works and is prepared to offer instructional workshops to explain his lesson plan to anyone who wishes to teach bridge to schoolchildren. I hope that several of you will take this opportunity to introduce bridge into schools because the future of the game depends on getting the younger generation interested. Many thanks to you Myron, this is a major breakthrough.

Finally I wish to thank all the Unit Associates, club managers, directors and teachers without whom the Unit could not function successfully. Over the past year there have been several changes. The caddy

master position has been taken over by Delores Hedley, thanks to Mike D'Aguiar; the mentorship has been taken over by Brian Johns and Sandra Evans, thanks to Nancy Stewart; the photographer position has been taken over by Milt and Sharon Mansell following the passing of Susan Julius, she will be greatly missed; Unit assets have been transferred to Barbara Webster in recognition of the fact that she has been doing the job for some time, but thanks are due to Steve Lawrence the nominal position holder; notices have been assigned to David Ho, thanks to Crystal Mann who has held the position for some years; and finally Jim Murphy who has taken over the new position of Unit trailer and maintenance.

This concludes the report.

TREASURER'S REPORT

MARCH 31, 2018

The Unit's financial transactions for the year ending March 31, 2018 generated an operating surplus of \$738. This outcome resulted from a combination of positive and negative items.

Noteworthy are increased revenues of \$4,092 from the four Sectional Tournaments held in the year. Our tournaments continue to generate record attendances, with 2017-2018 table counts exceeding the 2016-2017 counts at every tournament. In total, Unit revenues from all sources in 2017-2018 were up by \$2,249 or 15% compared to 2016-2017.

Offsetting the increased revenues, the Unit spent the following unbudgeted amounts: the net cost of the Novice (299'er) tournament in November 2017 was \$1,359: the special meeting of members on March 24, 2018 to approve our new bylaws cost \$1,790. In addition, our Rookie-Master event in February 2018 was cancelled due to heavy snowfall. Expenses of \$1,897 were incurred, with no offsetting table revenues. In the previous year, expenses of \$1,968 were offset by table revenues of \$1,490. Total expenses of the Unit in fiscal 2018 were \$16,833 and increase of \$4,879 or 41% compared to fiscal 2017.

All other items in the Statement of Operations were in line with the amounts budgeted. Members' Equity rose to \$40,212 as at March 31, 2018.

The budget for 2018-2019 was approved by the Board of Directors at the May 15, 2018 board meeting.

The Unit owns a trailer, bidding boxes, tables, boards with cards, Bridgemate terminals and a board duplicator. These items were expensed when purchased and are not capitalized on our Balance Sheet.
