BACK FOR THE FUTURE

The Board of Directors is pleased to announce that we are retracing the steps of our past and returning our sectional to the Jubilee Auditorium. We have a long term booking there; provided that none of those horrid problems we have had in recent years pop up we will remain for some time at one site.

This location is superior for any sectional needs. Although it does not have on-site hotel facilities, you will discover there are many places to eat and stay nearby. The site includes a separate room which we can use as additional playing space if required, and which will enable us to continue our novice hospitality program, financed from the 50-50 draw you all support so well.

The facility is clean, bright, accessible, and staffed by the same friendly faces many of you will remember from our stay there between 1976 and 1981. Those of you new to this facility are in for a treat from the staff — fun people who always enjoyed bridge players. The lobby area is huge: smoking during the hospitality breaks in this area should not cause concern to those with allergies.

We rent the space only at the Auditorium. This means we retain complete control over catering and hospitality costs. We will not be at the mercy of a hotel surprising us from one tournament to the next with incredible increases in costs. The ability to control our expenses in this area means that not only can we increase or decrease the level of service according to our changing means from time to time, but that we also can experiment with different types of services to learn what best suits the players.

The Auditorium controls the beverage services — they have a flexible liquor licence and their prices are reasonable (75 cent coffee, \$2.50 - 3.00 drinks). We will try to have them supply decaff in the evening sessions, and see how that flies.

Some of you will be concerned about parking. First, parking will be either free or at a very nominal rate (a dollar or two) depending on whether there is a mainstage function. Parking is available both in the north lot and the ACA lot, which has covered access to the building. Mainstage events are always at 8:00PM, and in order to avoid line ups we have changed our evening session time—check your program!!! Should you choose to arrive between 15 and 30 minutes ahead of the session, you should have no problems with the parking line-ups sometimes experienced by late-comers to the theatre.

At our meetings with other Alberta Units held in August, we agreed to hold our sectional as follows: 1. the first weekend in January which is not January 1st, 2. the third weekend in March, 3. Labour Day weekend, and 4. as early in November as the Banff Park Lodge can book us. Unfortunately this year the Auditorium is not available the third week in March, so we have planned that tournament for March 8-10. Future years are pencilled in according to the above schedule.

Come one, come all and help us celebrate the return of Unit 390 to its classy, friendly and hospitality-filled sectional.

GRAND NATIONAL TEAMS

We told you there would be changes, and there sure are. First, there are four flights now. Flight "A," the open flight, is not open to Canadians, as we have the CNTC event for that.

Flight "B" is new. Its bracket is 0-1500 master points. You qualify at the club level directly for the District Final. Qualified teams from District will go on to a National Playoff.

Flight "C" (formerly "B") has been changed to non-life masters. There is no masterpoint range in this category — if you are not yet a life master, you qualify. This category has a club qualifier into the Unit Final, and half the field will qualify for the District Final. Qualified teams from District will go to a National Playoff. This level is very exciting as the club qualifier will offer red points and the Unit Final will be half gold and half red.

Flight "D" (formerly "C") remains a 99er's event. It will be run as last year, with a Unit Qualifying event for a District Final. The ACBL has not yet seen fit to allow this event into a National Final.

You can play in any events you qualify for but the District Final will be held in Great Falls in April simultaneously so a decision will be required for each team before then.

We are told that the Clubs and the Special Events people have all the conditions. Unit finals will be held at the Martinique. Should you have questions (such as when you lose your qualification, or when are various dates), you can contact the Martinique, Juan Alvarez, or Linda Thierman.

The costs of these events will be borne at a loss by the district, and the unit will not be raising any money either. The district will be offering no subsidies this year; the unit is looking into ways to assist the rookie level, but please don't count on anything when making your plans. Bear in mind that this is the most inexpensive way there is to get those coloured points, and also some of the best competition available. Participate at some level, if you can.

THE RECORDER

The main duty of the Recorder is to receive written information, complaints and suggestions by players about other players, directors, facilities and anything else directly related to bridge.

The Recorder keeps ongoing records of all grievances brought to his attention, the facts of which he is able to verify. Absolute confidentiality is observed.

The Recorder has no punitive power. If a hearing does take place, the Recorder's records may be made available to the committee as evidence.

The Recorder will review memos received and determine how the issue is to be acted upon. He may investigate to determine the facts and possible extenuating circumstances.

The Recorder acts as an educator. Many players do not understand ethics and rules. The Recorder is able to help newer players, and others, become aware of each player; ethical responsibilities.

Unit 390's Recorder is Gordon Campbell. Recorder memos are available at most clubs, however you can write your own memo to Gordon, stating all the facts of the situation, including the dates and the names of the people involved. Gordon can be reached at 270-0315; his address is 448 — 13 St NW, Calgary T2N 1Z2.

The Recorder does not replace the director. He is, if you will, your sounding board about situations in which you have uncertainty and he will either help you understand certain situations, or will record occurrences which require further attention. Action will not necessarily be taken, but observations will be made and investigations, if warranted.
